Committee Reports

Binford Sloan reported that there would not be any committee reports until the January meeting.

Conference Coordinator's Contract – NCPTA Advisory Council received bids from NC State University-Continuing & Professional Education (\$6551.78); MP&E (10,000.00); and Mrs. Nixon (\$7500.00).

After discussion, Diane Grumelot made a motion to accept the bid from NC State Continuing Education & Professional Education. Chris Jones seconded, motion passed'

Summer Conference 2009

Binford Sloan presented information that the Board of Directors of Sea Trail at Sunset Beach, had decided to get out of the rental business. They had laid off staff and were not guaranteeing any rental units after December for the Summer Conference. Binford also reported that the NCPTA could get out of the contract with Sea Trail for the Summer Conference site without penalty. After discussion, a motion was made by Terry Campbell to dissolve the contract with Sea Trail. Dianne Grumelot seconded and motion passed.

Binford Sloan reported that he had talked to Mike Martin with NAPT, and he suggested that the NCPTA select 2 to 3 other sites and let NAPT negotiate with them.

Binford Sloan presented information on five RFP's that he sent out. The sites were:

- Raleigh Convention Center (Marriott/Sheraton) in Raleigh, NC
- Sheraton Downtown in New Bern, NC

as the sites to be submitted to NAPT for negotiations for Summer Conference 2009; with separate geographic areas for 2010.
